



SCHEDULE OF RATES

EFFECTIVE June 01, 2022

For vessels inbound and outbound charges shall be based on "PILOT UNITS". "Pilot Units" shall be determined by multiplying the overall length of the vessel, by the extreme breadth, by the moulded depth and dividing the total by ten thousand as expressed in the following formula:

$$\frac{L \times B \times D}{10,000} = \text{Pilot Units} \times \$13.00$$

Minimum Charge:

150 Pilot Units, inbound and outbound, in addition to Fuel Surcharge and Capital Construction Fees.

Maximum Charge:

790 Pilot Units, inbound and outbound, in addition to Fuel Surcharge and Capital Construction Fees.

DEFINITIONS:

- (a) "Overall Length" is the distance between the forward and after extremities of the vessel.
- (b) "Extreme Breadth" is the maximum breadth of the vessel including overhanging structures.
- (c) "Moulded Depth" is the vertical distance at amidships from the top of the keel plate to the uppermost continuous deck, fore and aft, and which extends to the sides of the vessel. The continuity of a deck shall not be considered to be affected by the existence of tonnage openings, engine spaces, or a step in the deck.

All measurements shall be in feet and inches (U.S.).

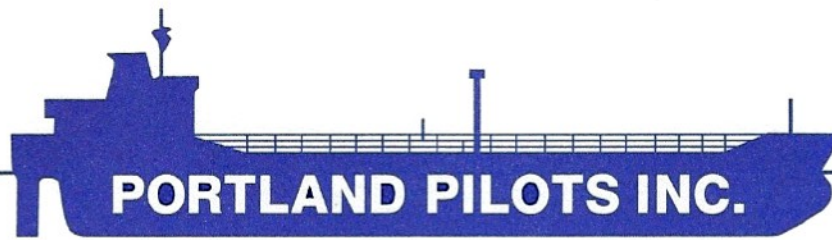
SPECIAL CHARGES AND RATES:

Pilot services for movement of vessels from Cousins Island to Portland Harbor or Portland Harbor to Cousins Island: 100% of prescribed rate.

To Hussey Sound for repairs or awaiting berth, Portland Harbor: 100% of Regular Rate.

Standing by with Pilot Boat per hour: \$400.00

Vessels of 150 Pilot Units or less requiring Pilot services in excess of two and a half hours shall incur a surcharge of \$400.00.



Pilot carried away to Sea. Detention Rate: \$1,000.00 per day plus all expenses incurred during and including return to Portland, Maine.

Cancellation Fees:

Arrivals cancelled with four hours' notice or less: \$400.00
Departures cancelled without two hours' notice: \$400.00

Cancellations during transit while piloting:

Pilot onboard and engaged in Piloting less than 1 hour: 25% of prescribed rate.
Pilot onboard and engaged in Piloting more than 1 hour: 100% of prescribed rate

Fuel Surcharge:

Pilot Boarding Area: "P" Buoy \$200.00 one way.
Pilot Boarding Area: Witch Rock \$150.00 one way.
Shift to Hussey Sound from Portland Harbor
or to Portland Harbor from Hussey Sound: \$100.00 one way.

The Fuel Surcharge will be reviewed annually on May 14 and the rate will be adjusted if the average cost increases or decreases more than 5% from the previous year. Charges go into effect June 1, 2022.

Capital Construction Fund:

Any vessel inbound transit from sea \$175.00
Any vessel outbound transit to sea \$175.00
Any vessel shifts from Portland Harbor to Hussey Sound \$175.00
Any vessel shifts from Hussey Sound to Portland Harbor \$175.00

Invoices paid by Credit or Debit Card will be subject to a 4% transaction fee.

A 1-1/2 % per month finance charge will be added to accounts past 30 days.
